### Endowment Fund Update and Q&A with Jean Prawley

Current Balance as of 05/15/2019 \$1,698,868.17 is up from 2018 at 12.3% 2019 YTD Value 12/31/2017 was \$1,597,690.64 Value 12/31/2018 was \$1,512,132.02 which was down 5.4% 2018

We need an Investment Statement developed so we can meet goals and growth. We are concerned about diversity of funds and allocation to be conservative with the endowment nature We previously had some bonds, but we got out of bonds due to interest rate changes 3 years ago; she would recommend moving back into the bond market by 10-15% at first Our goals should change for dividends or growth to get income

Jean has advised she is not a Managed Money broker, which has inherent 1.5% fee on type of fund fees Bond Acquisition is fee free, and her fees are only at buying funds, not bonds Our concern is about fee structure within her managing the fund and what is included in each funds Each fund issues semi-annual report that discloses fees inherent to the funds. Merrill Lynch is a managed money structure, has cost of 1.5% which comes at a cost of \$25k
